a. Maidenbrook Country Park & Somerset Wood: (R)

Country Park Volunteer co-ordinator explained plans for the Remembrance Day Service which will take place on the 10th November at 2pm.

There continues to be a lot of vandalism in the Country Park where volunteers are having to clear up rubbish and broken glass. The Country Park Working Group continues to look into solutions to the problem.
